Reminder of Club/ Promoter responsibility

- Event Change:** Any date change, location change or cancelation, the club or promoter representative must contact the applicable District 16 referee as soon as possible.
- Reports:** Clubs and Promoters need to complete all AMA Referee reports including injury reports and submit all proper information to the AMA and District on a timely basis, usually within 48 hours of the event, or per AMA rules.
- Contact Info:** If any contact information changes for the club/ promoter, or anyone listed on this Charter form, the District Secretary and applicable Referee(s) need to be notified immediately.
- Results:** After an event, results must be sent to the District referee within 48 hours in a manner suitable and agreed to in advance for that division.
- Rider Registrations:** All District 16 Rider Registrations, both annual and one day must be sent to the Membership Services office within 48 hours after the event with the appropriate payment. It is the club/ promoter's responsibility to assure these are legible and complete, including a current AMA number as possible. Keeping a hard copy of these forms is a good ideal as well.
- Rider Participation:** All riders participating in the event must be registered with District 16 if required by the rules summarized below:
 1. All participants living within District16 boundaries must be a member of the AMA or ATVA and possess or purchase a current year District 16 Registration Card. AMA current Pro licensed riders will be exempt for this rule. Verification is the responsibility of the hosting club/promoter.
 2. Clubs and promoters holding competitive events shown on the AMA District 16 schedule, points and non-points paying, not verifying and selling District 16 Registration cards will be considered in violation of the rule 1. Clubs/ promoters accepting seven or more event riders without District 16 cards will pay a \$100 fee for each event/ day. An additional \$10 per rider will be charged for the eighth such rider entry, and each additional rule 2 violation entry at this event. Excessive violation of this rule may also place future event scheduling in jeopardy, as determined by the District 16 board.
- Annual Meeting:** Clubs and Promoters are required to attend the annual meetings of AMA District 16, in person or by sending a responsible representative.
- Follow all rules of the American Motorcyclist Association and AMA District 16.
