

# AMA District 16 Council American Motorcyclist Association

## Supplemental Rules for Enduro- 2019

The AMA racing Rule Book applies to all AMA District 16 organized events. AMA district 16 organized events include but are not limited to Competition, meetings, banquets and awards ceremonies. All participants living within District 16 boundaries must be a Competition member of the AMA or the ATVA and hold a current district 16 registration card.

## I. District 16 ENDURO AWARDS POINTS

- A. District 16 points will be awarded to District 16 members who hold current AMA and District 16 membership cards. (See General Rules Section J)
- B. District 16 points will be awarded for the position that the rider finishes in both class and in overall. All non-District 16 riders will be removed from score tallies before points are calculated for the rider's class points and overall points.
- C. District 16 points will be awarded as follows:
  - 1. District points will be earned in each class at each enduro of 50 miles or more in length (Or closed course Enduro that is three or more miles long and is covered two or more times by the rider) to the rider on the basis of finish in his/her classification. In addition to class points, A class riders will also earn points towards the overall Grand Champion. All points will be awarded as follows:

- 2. District 16 Senior points will be earned at each enduro of 50 miles or more in length (or closed course Enduro that is three or more miles long and is covered two or more times by the rider) to the Senior riders on the basis of finish within the class. Points earned in either Class A or Class B cannot be transferred to the Senior class; nor can the points earned in Senior class be transferred to A or to B class.
- F. In all classes, total yearly points will be used to determine yearly winners.
- G. Points received for any District 16 Enduro held after October 1stst will be awarded for the following competition year.
- H. Riders must have made it at least to the first check point to receive district points for that enduro.
- I. Worker Points: Workers will be awarded 35 points after working 8 hours + the day of the event, for one event per year. Worker points for a second and third event (max of 3) will be the awarded based upon the average of the points won during the year in events the rider has raced with a minimum of 15 points per event.
- J. Worker points in the "C" class to go towards class placement and not "C" to "B" advancement when the C rider has competed in less than 50% of the years events.
- J. Participation Points: A rider will earn one participation point for every event ridden and two participation points for every event worked.

EX: A rider rides 3 events and works one event would earn a total of 5

participation points: 1+1+1+2=5.

- M. The overall District 16 Champion will be scored on the overall finish positions at each event.
- P. Any "A" class rider who does not ride the entire enduro course will not be included in Overall "A" Grand Champion year end points.
- Q. MASTERS and "C" class riders will run the "short course" at all events where it is offered by the promoting club.

## II. ENDURO AWARDS SCHEDULE

- A. A rider must earn a minimum of 3 participation points to qualify for yearend awards. (See Section I item K)
- B. Enduro awards will be announced and riders will receive their awards at the annual District banquet.
- C. Awards will be given in the following classes:
  - 1. Class: Overall Champion; AA, 0cc-Open cc A; Vet A, ages 30-39, Senior A ages 40 -49,
  - 2. Super Senior ages 50 to 57, Masters age 58 years and up.
  - 3. B Class: 0cc-Open cc B; Vet B and Senior B (see above ages and cc restrictions)
  - 4. C Class: 0-Open cc; If 4 or more registered District 16 riders show up for a women's class this class will pay end of the year awards.
- D. Awards and trophies for individual events will be left to the discretion of the sponsoring club
- E. A club shall not have to award trophies to more than 20% of the riders in a class.
- F. Points for yearly awards will be based on a 30-25-21-18-16-15-14, etc schedule, per the AMA Rulebook.
- G. Throw-aways: There will 1 throw-away. The lowest scoring/non participation event will be removed before calculating year end final points.

## III. Advancement

Participation in or advancement to a higher class in any AMA or non-AMA Off-Road meet by any rider will result in permanent advancement to that higher class in all AMA sanctioned Off-Road competition. Off-Road racers will ride all off-road meets in the highest classification earned. Off-Road includes Enduro, Hare Scrambles, Desert Scrambles, Grand Prix, Cross Country, Hare and Hound and like type meets.

## **Off--Road National Advancement System**

1. Riders will receive advancement points for participation in all AMA-sanctioned enduro, hare scrambles, desert scrambles, cross country, grand prix, hare and hound (or any similar

activity) meets. AMA riders advance from one classification to the next through their Successful participation in AMA-sanctioned meets.

- 2. Advancement points will be calculated from Dec.1st to Nov. 30th each year. Riders will be advanced effective Jan. 1st of the following year.
- 3. Riders between the ages of 12 and 15 on Nov. 30th riding the B classification shall not be forced into the A classification regardless of how many B races or advancement points he/she has. Riders in this age group may advance based on their own ability/competence.
- 4. In series' that roll over into a new year, riders must begin the series in the classification they will compete in during the new year. A rider can't continue racing their classification from the previous year if they are no longer eligible as of Jan. 1.

#### **Off--Road Performance Value (ORPV)**

Note: Non-District riders are NOT removed when calculating ORPV.

To be considered for advancement a rider must have a minimum of six points-paying finishes within the rider's classification. Race results that have a DNF, DNS overall finish or zero advancement points will not be used for calculating a rider's advancement ORPV.

#### "B" Classification Advancement

All B riders carrying an ORPV of 15 or higher at yearend will be advanced to the A classification.

#### "C" Classification Advancement

All C riders carrying an ORPV of 15 or higher at year-end will be advanced to the B classification.

The following criteria are to be used when determining a rider's eligibility for the C classification:

- (1) No rider is to be classified as a C rider if that rider had an ORPV of 15 or higher the previous year in the C classification.
- (2) No rider is to be classified as a C rider if that rider has ever been classified as an A rider.
- (3) No rider is to be classified as a C rider if that rider is receiving or has ever received any type of OEM factory support in any classification. (Excluding OEM contingency and trackside support)
- (4) If a rider doesn't meet any of the above criteria, they may not participate in the C classification if they have raced C the previous two calendar years and have an ORPV of 11. 0 or higher.
- 9. Riders who race in MX, Enduro, Hare Scrambles, Hare & Hound and have different classifications in each type of racing may not vary more than one level.

\*Example: A rider has 18 B classification entries. He earns 256 points combined in 15 of those entries and no points in the other three. To calculate the ORPV the total points earned (256) are divided by the total number of classification entries in which points were earned (15). 256 divided by 15 = ORPV of 17.06. The rider's ORPV of 17.06 exceeds the 15 point cutoff and he/she is advanced to the A classification.

## IV. ENDURO EQUIPMENT

- A. Equipment must be manufactured for the express purpose of being used on motorcycles and the equipment must be mounted in a safe and secure manner.
- B. All motorcycles must have a safe and securely fitted exhaust silencer/ US Forestry approved spark arrester which must be intact at the end of the enduro.
- C. It is recommended by the District 16 Council that an equipment check be made by the District Referee and/or the event referee at the time of the enduro. Any malfunctioning equipment must be repaired to the referee's satisfaction or the rider will be disqualified
- D. Rider to make every reasonable effort to compete on a motorcycle that is at or below the AMA's 96 decibel limit at all events where the promoting club does not require a sound check to be passed before competition.

#### V. COMPETITOR BEHAVIOR

- A. Riders should not put themselves in a position to jeopardize other riders, land, animals, and/or spectators.
- B. Slower riders should give way to faster riders.
- C. Riders should report all unusual conditions to persons operating checkpoints, referees, layout crews, and/or the police.
- D. Riders should refrain from smoking in fire hazard areas.

#### V. GENERAL RULES

- A. Final scoring may be done at the starting point. You may or may not elect to have an observed check at the finish point if this option is used. However, these conditions must be spelled out on the route sheet so all riders are informed.
- B. When a rider carries his own score card and loses it, 10% of the points lost will be assessed with a minimum of one point, and any fractional parts will be rounded off to the next highest whole number. The affected rider must be scored upon request to the referee. District 16 riders must identify their score cards with a 16 within a circle on the top of the score care to get district 16 points. For those events scored electronically, and have backup scores taken, the electronic identification tag or transponder will be treated like the riders score card for this rule.
- C. District 16 will adopt the new AMA rules on the AA Enduro Class with the following clarification: a minimum of 6 riders necessary to run the AA class. If there are not 6 riders, the AA riders will be eligible only for the overall trophy.
- D. District 16 will permit a timing device error of ten seconds
- E. Class Structure for AMA District 16:

A Class: AMA riders, 0-200cc; 201-Open cc;

B Class: 0-200cc; 251-Open cc;

C Class: Any displacement will run in one designated class;

Age Classes: on any size machine;

Veterans A & B: riders between the ages of 30 and 39;

Senior A& B: riders ages 40 to 49;

Super Senior, ages 50 to 57;

Masters, ages 58 and older;

Buddy: a rider with a passenger;

Power Puff: female competitors;

Novice: a first time rider for no trophies or points paying a reduced entry fee of 50-60%;

- F. Individual categories or displacement classes will be recognized at an event at the discretion of the promoting club and would depend on the number of entrants.
- G. Those riders who are classified as District 16 B Riders will be notified prior to the first enduro or at sign-up. All C class trophy winners will be checked against District B rider list at each event.

If a District B rider is found to have entered as a C rider, that rider will be disqualified for that day's event.

- H. The district referee will be given free entry on race day.
- J. Rider Participation:

All riders participating in the event must be registered with District 16 if required by the following points:

- 1) All participants living within the District 16 boundaries must be a member of the AMA and possess or purchase a current District 16 membership card. Verification is the responsibility of the hosting club/promoter.
- 2) Clubs and promoters holding competitive events shown on the AMA District 16 schedule, points and non-points paying, not verifying and selling District 16 Registration cards will be considered in violation of the rule 1. Clubs / promoters accepting seven or more event riders without District 16 cards will pay a \$100 fee for each event/day. An additional \$10 per rider will be charged for the eighth such rider entry, and each additional rule-2 violation entry at this event. Excessive violation of this rule may also place future event scheduling in jeopardy, as determined by the District 16 board.

#### **PROTESTS AND OFFENSES**

A. The AMA rule-Book and the District 16 Supplemental rules will be observed. If these must be modified in the best interests of the overall event, a three-person committee of neutral parties, including the event referee, the District referee and one other person will make the required decisions.

VI. **CONDITIONS OF THESE BY-LAWS** may be altered by the approved method of amendment as set forth in the AMA District 16 Council Constitution.
